The Standard Occupation Classification for the FDS (SOC (FDS)) contains numeric codes of up to 4 digits. However for Fields 12 and 14, the specified field length is 6 and field type alphanumeric. This is because the CASOC (Computer Assisted SOC) package can generate a code of 4 digits followed by 2 letters. Institutions using CASOC may therefore use all 6 characters, i.e. 4 digits followed by 2 letters. Institutions not using CASOC should return 4 digits followed by 2 blanks, i.e. the field should be returned left justified with trailing spaces.

The Standard Occupation Classification for the FDS (SOC (FDS)) contains numeric codes of up to 4 digits. Within this framework, a trailing zero (i.e. the fourth digit is zero) is used to indicate the fact that no further distinction is made below the unit group (3-digit) level. Thus in many occupations there exists only one 4-digit category, which is simply the corresponding 3-digit category plus a trailing zero. In all cases a trailing zero can be added to a 3-digit category when no further distinction is possible.

The Standard Occupation Classification for the FDS (SOC (FDS)) contains numeric codes of up to 4 digits. However for Fields 12 and 14, the specified field length is 6 and field type alphanumeric. This is because the CASOC (Computer Assisted SOC) package can generate a code of 4 digits followed by 2 letters. Institutions using CASOC may therefore use all 6 characters, i.e. 4 digits followed by 2 letters. Institutions not using CASOC should return 4 digits followed by 2 blanks, i.e. the field should be returned left justified with trailing spaces.

The Standard Occupation Classification for the FDS (SOC (FDS)) contains numeric codes of up to 4 digits. Within this framework, a trailing zero (i.e. the fourth digit is zero) is used to indicate the fact that no further distinction is made below the unit group (3-digit) level. Thus in many occupations there exists only one 4-digit category, which is simply the corresponding 3-digit category plus a trailing zero.
